The Utah Assembly Notice of Intent — Schedule of Charges for Trespass and Harm

Let it be known to all on this _____ day of _____, Two-Thousand and Twenty-Five, Anno Domini, that it is the unanimous will of the men and women of The Utah Assembly, functioning as the sole lawful Government on Utah, to establish and maintain charges to be instated and mandated against any and all entities who in any way attempt to engage Lawfully and Properly declared American(s), be they American State Nationals or American State Citizens, in any form of malfeasance, fraud, harm or other trespass.

We are Utah, properly declared American State Nationals and American State Citizens, who embody the values of Peace and Honor. We reject into perpetuity all non-voluntary business, non-volitional or unconscionable contracts, compelled performance, and any and all other non-voluntary, coercive, threatening, or non-consensual transactions whatsoever, in any jurisdiction, realm, dimension or circumstance that are in any way detrimental to body, mind, soul, spirit or property; or that otherwise interfere with the enjoyment of a Natural and Organic Life as is ordained by The Creator.

Any man, woman or other entity who acts in violation of our right to the Law of Peace or our Freedom, will be invoiced accordingly. Charges are due and payable on demand in lawful money (United States Silver Dollars), at face value of coinage as designated herein at the conclusion of each transaction.

Charges enumerated herein are applicable per-occurrence, and include any and all third party(s), agency(s) by estoppel, any and all Territorial United States District and State and County Courts, their agents, officers, clerks, bailiffs, sheriffs, deputies, and employees and all Municipal Appointees including their DISTRICT COURTS, STATE OF STATE COURTS, and COUNTY COURTS, their OFFICERS, AGENTS and EMPLOYEES of same that wish to engage the aforementioned American State Nationals or American State Citizens in non-volitional actions, actions or experiences.

Furthermore, any man, woman or other entity in receipt of this The Utah Assembly Notice and Intent Schedule of Charges for Trespass and Harm are hereby given Lawful Due Notice and full disclosure of the following, and shall be liable severally and jointly, without benefit of Corporate Veil, Immunity, Indemnification or any other evasion of responsibility and accountability. This schedule of charges stands as an affidavit of obligation in the normal commercial sense, representing accounts receivable and is a lien upon the real, personal and movable property, malpractice insurance and performance bonds of any such violators and is not dischargeable in bankruptcy court or subject to any probate claim.

The hourly rate of exchange is \$100,000, with accrual 24 hours per day, 7 days a week, 365 days per year. Any additional crime or interference will be invoiced at the rates listed below. The minimum charge for all non-voluntary transactions is one hour (\$100,000). Any other action, trespass or instance of harm or damage not listed







below is subject to designation or modification of hourly fee at discretion of The Utah Assembly and/or the man, woman, son or daughter who is harmed or trespassed upon.

Any undesired action that brings deleterious effects upon, within or to, our individual body, mind, soul, spirit or property by force and/or under duress is subject to an hourly rate of exchange that is doubled. This is to include but not be limited to fraud, interference, obstruction, embezzlement, extortion, impediment, coercion, theft, threat, duress, assault, intimidation, abuse, battery, stalking, harassment, detainment, kidnapping, press-ganging, defamation, resistance, inland piracy, and/or any other trespass, harm or loss.

For any action stated herein that is deemed to be punitive or particularly egregious, the hourly rate of exchange is trebled.
