Article 742. Our Situation Report

Truly understanding where we are requires a knowledge of where we have been in the past--- and that is not easy to come by, both because the facts have been obscured by guilty parties and because most people have not been motivated to learn.

So that we can hit the highlights and get up to speed in the present----

Part I -- We Begin

1. The government of this country is vested in its people. "People" means "militia" in Hebrew. There is no doubt that the Founders meant for the government to be created and controlled by the same militia men who defended the country then and who defend it now.
2. The actual government is an unincorporated business known as a Body Politic.
3. The name given to this Body Politic on September 9, 1776, was: The United States of America.
4. This is a totally unique unincorporated entity and we hold its Declaration of Independence and its Letters Patent and its sacred name under Common Law Copyright in perpetuity.
5. The United States of America is not a sovereign nation. It is a consortium known as a "union" of sovereign nations.
6. Thus, when you look at this country, what you are actually seeing are fifty smaller countries, each with their own history, their own geographic boundaries, and their own natural government. In America the words "state" and "nation" are interchangeable. Thus, the "interstate commerce clause" can also be read as the "international commerce clause" and "Ohio State Bank" can also be read "Ohio National Bank".
7. For their mutual benefit, these independent small countries banded together and formed the union called The United States of America and they delegated their international jurisdiction (also known as "territorial jurisdiction"), both on the land (organized as Federal Postal Districts) and on the sea (organized as US Districts) to it.
8. The **unincorporated** union of sovereign states called "The United States of America" holds and exercises all their combined international "powers".
9. The United States of America then delegated nineteen of these international powers to the British-backed United States organization, lodged in the District of Columbia.
10. Neither of these organizations were incorporated originally. Each had its own population and its own geographical territory. This was the practical result of The Definitive Treaty of Peace 1783, which describes the two populations as "the free, sovereign and independent people of the United States" and the "inhabitants" ---British citizens--- who remained behind after the War of Independence to provide "essential government services".

11. This arrangement resulted in two Constitutions --- one in 1787 called "The Constitution for the united States of America" that separated out the international powers of the member states and joined them together under the auspices of The United States of America (unincorporated), and one in 1789 called "The Constitution of the United States of America" which created The United States entity and its government to exercise the nineteen (19) delegated functions.

Part II - A House Divided

12. This unsteady dual sovereignty endured until the so-called American Civil War---- which was never declared as a war by the united States of America in Congress Assembled, and it was never ended by a peace treaty. As such, it was and remains an illegal commercial mercenary action on our shores.

13. Following the end of the armed hostilities, a completely new incorporated entity merely calling itself "The United States of America" (Incorporated) was launched in 1868. Unlike the actual unincorporated government it was deceptively named after, this was a incorporated entity like any other. The Congress ceased acting in their public office and began functioning as a corporate Board of Directors.

14. The effect of this was glossed over and subtle and hard for the people to recognize, but it unlawfully converted our unincorporated government into an incorporated one, infringed on our copyrights to do it, and substituted a private, mostly foreign-owned corporation in its place. This in turn removed the government from the land jurisdiction and dumped it in the international jurisdiction of the sea.

15. At first this seemed to have little impact because the "federal government" and its international functions had always been operating in the international jurisdiction anyway. The switch from public interest to private interest went largely unnoticed, but the pilfering and mischief began--- and by 1907, "The United States of America" (Incorporated) was bankrupt.

16. Shortly before this, a series of Supreme Court cases known collectively as the "Insular Tariff" cases allowed the incorporated Municipal United States to expand its franchises into the geographically defined states. So when The United States of America (Incorporated) went bankrupt in 1907, its functions were immediately picked up by yet another version called "the" United States of America (Incorporated).

17. This second version -- another private, mostly foreign-owned governmental services corporation -- was bankrupted in its turn, first, internationally, by treaty among the G-5 nations in 1930 at the Geneva Conventions, and then domestically in 1933 by Franklin Delano Roosevelt.

18. This left us with two bankrupt foreign federal governmental services corporations, one called "The United States of America" (Incorporated) and another called "the United States of America" (Incorporated) and they conveniently named us and our states as the Sureties for their debts----so that our land was held as collateral for the debts of The United States of America, Inc. until that bankruptcy settled in 1953, and our labor and private property was conscripted and held as collateral for the debts of "the" United States of America, Inc., until that bankruptcy settled in 1999.

Part III - The Filthy Bastards

19. During the bankruptcy of both of these incorporated entities, more fun and games ensued with new incorporated entities that merely moved into town and "assumed" the vacated service contracts owed to us under the actual Constitution --- enter the UNITED STATES (INC) and USA (Inc.). One, the UNITED STATES (INC.) being a Municipal corporation organized in France and the other, the USA, Inc., being a Territorial corporation organized in Puerto Rico--- and both being foreign to us and to our states and having no proper contract or affiliation with us whatsoever.

20. In international jurisdiction it is possible to act as a "successor to contract" and to "assume" a contract, so long as nobody objects, and since nobody but the perpetrators of this system knew what was going on at the time, nobody objected.

21. Now, as of May 2015, the UNITED STATES, (INC.) is in Chapter 7 Liquidation and as of this year, 2017, the USA, Inc., is in Chapter 11 Reorganization.

22. It is the obvious plan of the perpetrators to pull the same tricks again and make the clueless Americans pay for it all. As preparation, THE UNITED STATES OF AMERICA was incorporated under the municipal (city-state) auspices of the United Nations to take over the lucrative governmental services contracts of the bankrupt UNITED STATES (INC.) and a new territorial entity calling itself "Republic United States" has been formed as a Nevada Corporation. Still more contenders have been formed off-shore, including a new thing out of Costa Rica calling itself "The United States of America" (Inc.---again.) and The Unity States of America (Inc.) and so on.

23. During this time period, American babies were seized upon as chattel backing the debts of these corporations under conditions of non-disclosure and deceit and deliberately misidentified as the progeny of unwed Mothers surrendered as wards of the incorporated "STATES". Their worldly goods--the copyrights to their Names, their land, their homes, their bodies, and even their souls-- were "securitized" and traded as assets and were presumed to be "donated" to benefit the incorporated "States of States", while they themselves were deemed to be paupers and incompetents and slaves owned by these respective commercial corporations.

24. These gross criminal acts of personage and barratry against innocent civilian populations, fraud and breach of trust with respect to international treaties, violation of commercial contracts, institutionalized identity theft, unlawful conversion, acts of inland piracy against their employers, press-ganging, kidnapping, enslavement and other crimes perpetuated against the American states and people have provided a vast and insurmountable public record of infamy and led to the demand that these corporations be liquidated as crime syndicates operating on our shores.

25. We note that these activities continued on despite objection and evidence and regardless of which political party was in power. They continued even after they were prosecuted and given Notice under international law. Many of these crimes have been internationally outlawed for centuries and some are capital level war crime offenses. These crimes have been committed against Americans at home, and at the same time, the same perpetrators have committed these and similar crimes "in our names" while claiming to represent us abroad.

Part IV -- We Wake Up and Return Home

26. In 1998, things conspired so that some Americans woke up. Commander Russell Gould seized the Title IV Flag abandoned in the wreckage of the bankruptcy settlement of "the United States of America" (Inc.) and re-entered it in the United Nations. He also re-opened the actual Post Office in Philadelphia. Meanwhile, my husband and I served Notice to the Governors of the "States of States" and the Internal Revenue Service and the Queen and the Pope, objecting to the fraud and criminality and Breach of Trust involved in all of this.

27. For the next ten years we privately pursued Due Process and continued to give Notice to all parties concerned and conducted the necessary research and discovery to determine and demonstrate both Breach of Trust and violation of Commercial Contract with respect to us and our states of the Union.

28. In 2008, our complaints were heard by the Vatican Chancery Court and a determination made by Benedict XVI in our favor and efforts to remedy began, including a Final Order defining once and for all the naming conventions and tax statuses of all the "named vessels" involved in this chicanery.

29. By 2011, we had re-opened our Federal Postal District Courts and began the final series of Due Process presentations throughout the land jurisdiction occupied by our sovereign unincorporated states.

30. In April 2014, we issued Final Judgment of Breach of Trust and Violation of Commercial Contract. We gave international Notice and Due Process to all Principal Parties and many, many agents and agencies.

31. On November 4, 2015, we issued new Sovereign Letters Patent, and on November 6, 2015, inclusive Sovereign Letters Patent and a Joint Declaration of Sovereignty together with the American Athabascan and Lakota Sioux Nations. By so doing we preserved our actual Constitution and chose new "federal" partners indigenous to this country. This was again given full Due Process and international Notice.

32. We solicited and processed claimants from all fifty land jurisdiction states competent to inherit the land as heirs and as representatives of the people, jural assembly members, and members of their respective state militias going back before the so-called Civil War and most before the War of Independence. These Americans also signed paperwork making their political status explicit and placed it on the public record, so that there can be no doubt that all fifty land jurisdiction states are occupied and possessed by lawful heirs.

33. On January 6, 2017, we issued a series of Private Sovereign Indemnity Bonds securing the claims of the American states and people as Priority Creditors and Paramount Security Interest Holders against the UNITED STATES and all of its various franchises including the STATES OF STATES, and also against the USA, Inc. and its franchises including the States of States.

34. Also on January 6, 2017, we issued a Payment Bond and lodged it with the Vatican Chancery Court, which is the bank for the Holy See, and redeemed all the Named and NAMED entities worldwide.

35. We, the American states and people, are the Priority Creditors and Paramount Security Interest Holders of all Municipal governments and all Territorial governments and all the various corporations formed under the auspices of these governments worldwide.

Part V -- A Brief Practical Explanation of the Circumstance

36. Two dreadful World Wars had left the entire Earth suffering and demolished. In 1945, simply cleaning up the wreckage seemed an insurmountable task and unbearable expense for most of Europe and much of the Far East.

37. The U.S. Army never stood down and the American states and people were "presumed upon" and never allowed to return to peacetime status. Our factories were never re-tooled, our taxes were never relieved, our entire country and its resources were pushed to the uttermost for decades after 1945 to rebuild and finance the rebuilding of the entire world.

38. This is why we have been worked like animals and enslaved and imposed upon for eighty years-- to rebuild after the World Wars.

39. Now, when it comes time to pay us back, the actual debtors--- all the many foreign countries of Europe and around the world, can't afford to pay us back. The debts are astronomical, in the quadrillions of dollars.

40. So all these "incorporated" municipal and territorial franchise governments doing business as, for example, "JAPAN" and "Japan", have all quietly, by treaty again, declared bankruptcy to discharge all this accumulated debt.

41. That is fine enough. We are wise enough to know about blood and turnips. And we didn't rebuild the world to lord it over our neighbors or destroy it again with another stupid war over money. However, there are some issues that cannot and won't be ignored.

42. The perpetrators of these plans and circumstances set it up so that we have not been represented. We, the Priority Creditors and Paramount Security Interest Holders have been studiously left in the dark, with the expectation that we would not step forward and tell the world these facts, which would then allow the international banks to act as Secondary Creditors and claim our assets as "abandoned property".

43. It isn't bad enough that everyone involved planned with malice aforethought to borrow all this money and labor and resources from us and then claim bankruptcy, but they further planned to make false claims on

abandonment and steal everything that belongs to us naturally, adding an insurmountable insult to already ripened injury.

44. So as we take our rightful place as the lawful and only true and actual government left standing, and settle our claim as the Priority Creditors and Paramount Security Interest Holders of virtually every government and every incorporated business on this planet, we have this to say---- it's our right and obligation to do justice and grant mercy, to live up to the best that America can be and turn our backs on what it has been misrepresented to be--- but our assets are ours and they are not abandoned.

45. Finally, we say, this system is at an end. We have published our conditional acceptance and told both THE UNITED STATES OF AMERICA and the Republic United States and all the other wannabe Successors to Contract, thanks but no thanks. Any services we receive, we receive on a limited and transitional month by month basis and we allow no assumption of contract beyond that. We have made our arrangements and we are conducting our own business, restoring the lawful government and the Public Law pending action to call a Continental Congress into session.

Part VI - America's Hereditary Head of State

46. In 1087 A.D. William of Normandy died and made his senior nobles, relatives of his from Normandy who made the Norman Conquest possible, "free sovereigns in their own right" in England. This is known as The Settlement of the Norman Conquest. The Belle Chers ---Anglicized to "Belcher"-- were among those so honored.

47. A little more than a hundred years later, they were among those who created and enforced the Magna Carta.

48. By 1609, they were among the first men to enter Boston Harbor and begin building the city.

49. By 1776, they were lawyers and neighbors of John Adams in Braintree, Massachusetts.

50. They were also officers in the Continental Army; William Belcher was a Colonel who fought in the Battle of White Plains and other engagements. He was also a free sovereign in England, having Elder Title, and outranking King George.

51. When The United States of America was formed to hold all the powers of the individual states in international jurisdiction and subsequently to delegate some of those powers to The United States, there had to be a Head of State to hold and exercise the "reserved powers" --- those powers in international jurisdiction that were retained by the American states and people and not delegated away.

52. The Head of State had to be a sovereign in his own right, and hopefully, someone who understood and supported the American vision. William Belcher was put forward by John Adams as a solution to the problem and his family Coat of Arms was thus employed to create both The Great Seal of the United States of America and The Great Seal of the United States.

53. Every American ship and "vessel" in trade or commerce that has set sail on the High Seas and Navigable Inland Waters since then has operated under his sovereignty and his seal.

54. James Clinton Belcher is the lawful heir and progeny of William Belcher and rightwise enabled to wield The Great Seal in whatever capacity and manner he chooses in international jurisdiction.

55. Though an artist by trade and fully loathing politics of all kinds, he has stepped forward in this hour of need to exercise those powers vested in him as the lawful Head of State owed to this country and has brought forward the claims of the American states and people as the Priority Creditors and Paramount Security Interest Holders in the worldwide bankruptcy, and he has also provided for their defense against false claims of abandonment, and provided evidence that their land and homes, businesses, and bodies are not chattel and not voluntarily standing as sureties for the debts of the UNITED STATES (INC.) and USA, Inc. which have

abused their employers and benefactors, trespassed and infringed upon our copyrights, plundered our national trust, and done so under conditions of fraud and deceit.

56. By posting the Private Registered Indemnity Bonds covering all the actual states and people and by posting the Payment Bond redeeming all the Names and NAMES of these vessels, we have completed everything necessary to reclaim and release the assets, set aside the debts, and restore lawful government to the entire world.

57. We have also rebutted all claims that we voluntarily abandoned, declaimed, or traded away our birthrights for petty considerations.

The governments of the world for the past 150 years have been run as crime syndicates with all the terrible results that we now see, but we have the opportunity as the Priority Creditors and Paramount Security Interest Holders to put an end to the evil that has been and give birth to the good that can be.

Dear Sirs,

My wife and I both come from the ancient race of the Coriosolites of Armorica, our homeland is in Northwestern France and our presence there was recorded by Julius Caesar prior to the Roman Conquest of England. Many artifacts and coins and records of our people still survive. Our ancestors, the Kings--both Bors and Ban of Gaul and Benoic (Benwick)-- held large portions of both France and England for many generations-- it is because of these facts that William the Conqueror had a valid claim which Edward the Confessor recognized.

That is the hidden history of the claim of William the Conqueror---hidden only because the British Government has hidden it in hopes of profiting themselves by chicanery and unjust enrichment then as now.

We have been free sovereigns in our own right in England since 1087 A.D. Our kinsmen wrote and enforced the Magna Carta a little more than a hundred years later.

In 1609 we came to America and by 1630 our direct progenitors were here, building Boston. It takes no great understanding of the world to grasp the fact that "America" is not a namesake of Amerigo Vespucci. It is the namesake of our ancient homeland, Armorica.

Nor does it take any sophistication to see the blazon of the Belle Chers (anglicized to Belcher) firmly established as The Great Seal of The United States of America and The Great Seal of The United States.

Take a look at those seals and comprehend what they mean.

The Great Seal of The United States of America is open. No border. No limit. Not a dependent sovereignty. The Great Seal of the United States is closed. Always encircled. Dependent on delegated power.

Nor does it require any great grasp of history to recognize that the British Empire has been the source of all the lies and misery that has infested the world for many generations. The present despots of the world think we have forgotten and that they are free to make whatever ridiculous lies and claims they please, but we are here and we know who we are and we do remember.

I am Hereditary Head of State of The United States of America (Unincorporated) standing on the land and soil of this country in full sovereign capacity. I am not now and have not acted in any foreign Territorial or Municipal capacity since I left the USAF in 1964 and gave full Notice of the same in 1998. Again. I have deliberately seized upon my own lawful Trade Name which was unconscionably presumed to be a derelict and abandoned "vessel" and have returned it to the land and soil of my native country. From there, I have seized back all derivative ACCOUNTS and re-flagged the VESSELS.

There can be no doubt who I am and in what capacity I am acting.

Let the record show that The United States of America (Unincorporated) was formed on September 9, 1776 and has never ceased functioning, never been at war since the signing of the Treaty of Peace in Paris, 1783, and has never been bankrupt, in abeyance, or otherwise entangled in the commercial feudalism of the United Kingdom by any official act of ours or our States.

The Territorial United States Government which has been organized as a commercial corporation in the business of providing governmental services since 1868 has grossly and unconscionably abused our delegated powers and worked a thoroughly reprehensible fraud scheme on our shores in contravention of both the Geneva and Hague Conventions. This foreign corporation has outrageously usurped upon us and our lawful government and other lawful governments around the world.

Unfortunately, as they have been (mis)representing us to the United Nations and have unjust enrichment as a motive for doing so, they have basically fed upon their loyal employers and attempted to displace them in Gross Breach of Trust via means of fraud and deceit and secretive substitution of their Territorial offices for our National offices.

The British Government and the British Crown is most accountable for this, along with the former Pontifical Office of the Holy See. These great wrongs have been fully admitted and then tossed into the air without responsibility being taken for the return of the property and assets and private belongings of the people worldwide.

Instead of an orderly and just settlement, too many parties have been trying to maintain The Lie and continue the abuse, most notably certain members of the British Parliament, the US Territorial Congress, the UNITED STATES GOVERNMENT, INC., and various mercenary agencies including the US District and Territorial Court Systems.

Mr. Trump is not responsible for nor guilty of any of this deplorable criminality; rather, he has inherited it from a long line of predecessors. We have the utmost sympathy for the position this places him in and support his efforts to clean up this Mess; however, we also realize that he has come into this office as a complete neophyte and that he is being lied to by experts who are anxious to cover their own tracks. So we are observing these matters for those with eyes to see.

The continued fraud and attempted identify theft of entire countries by these commercial "service" corporations has even extended down to the level of individual people who have had their persons deliberately mis-characterized as "citizens" of the Territorial and Municipal United States and even as corporate franchises of their commercial "fleet".

With the entry of the parent corporations of both the Territorial and Municipal United States into different levels of bankruptcy, it has been necessary for us to re-assert our dominion, recall our delegated powers, establish contracts with other federal service providers, serve Notice on all the Principals and Principle Parties (which we have done), report these crimes to the appropriate international authorities and bring forward our claims to assert our trust interests and recoup our assets, which the so-called service providers were holding-- and profiting from -- without our knowledge or consent.

The essence of the fraud lies in semantic deceptions and mistaken identities and resulting falsification of public records. We have many, many millions of innocent Americans who have been defrauded and purposefully entrapped and misidentified as Territorial United States and Municipal United States citizens.

We do not propose that the current situation of confusion and dereliction of duty persist at the hands of internationally appointed bankruptcy trustees chosen by Secondary Creditors of our Hired Help.

Their bankruptcy does not imply our bankruptcy, nor the bankruptcy of our States nor our people. It does not provide any excuse for seizing upon our assets or mis-addressing us in any presumed foreign capacity whatsoever.

This is your Due Notice of these facts.

All Americans coming forward to reclaim their Good Names and Estates must be recognized as innocent Third Parties and as internationally Protected Persons.

This is your Due Notice that there is no such thing as a "sovereign citizen" nor is there any such thing as a "private citizen". It is impossible to be a sovereign and a citizen at the same time. It is also impossible to be acting in a private capacity and a public capacity at the same time. We do not understand why the members of the Territorial Bar Associations and the Press Corps and the so-called "US Bankruptcy" Courts are still being ALLOWED to apply these oxymorons and label people "sovereign citizens" or dare to address their employers in this manner.

We object strongly to any presumption of the existence of any such frivolous and imaginary political status and we require the assistance of all international courts to stop this fraud upon the courts worldwide.

We call upon the United Nations Inspector General to clamp down on all UN Employees to be sure that none of them are mindlessly perpetuating these abuses and that you are enforcing proper recognition of American Vessels active in both International Trade and Commerce as operating in their private capacity, and upon President Trump to similarly put an end to these abuses.

I have been informed of several cases this week where law enforcement officers and petty officers in federated state and county courts have seized upon Americans and leveled these ridiculous "charges" of them being "sovereign citizens" and also attempting to pretend that these people who were going about their business and not bothering anyone were "obstructing" their operations.

Let us be perfectly blunt. These Territorial minions have no permission to be here addressing American people on their own shores and any commercial liability they create, they are accountable for. Any violence they perpetuate, they are accountable for. They have no right of presumption against their employers-- we, sirs, are their ultimate employers.

We are thoroughly sick of this "bully boy" attitude and abuse of the law, both international and commercial. This country functions under the American Common Law, not British Equity Law, not Territorial Statutory Law, and not under Municipal Code. Until the American Bar Association gets that drilled through their heads and forced to recognize the American people as lawful persons who are naturally outside the jurisdiction of their courts, there will continue to be despicable ignorance and abuse.

I believe that Mr. Trump is still holding the Office of Commander in Chief and it is his responsibility to inform these courts and the responsibility of the US Army to enforce discipline upon them and to properly administer the Law of Peace, FM 27-161-1, and that all Americans must be presumed to be the victims of this vast institutionalized fraud.

If there is any doubt in your mind that we have indeed corrected our standing which was impaired by deliberate fraud and falsification of the public records, I suggest that you look in the public records to see exactly where, when, and how we have removed ourselves and our "Vessels" from both Municipal and Territorial jurisdiction

and have established our permanent domicile on our land and soil and have furthermore brought these issues before the various international bodies and courts.

Our standing in this matter is iron-clad and all your members and all their courts have been given Notice and have date-stamped and filed and returned closure on these exemptions and these claims. Any idea that we are ignorant little bumpkins to be rolled by the press gangs and abused by commercial mercenaries need to end right here and right now. The Sleeping Giant has awakened and is exercising its reversionary trust interest. The "presumed" donors have returned from "over the sea" and there are now thousands of us awake and taking action, including eligible fiduciaries for all fifty states ---- people who have demonstrated their genealogy in this country prior to the so-called Civil War, which was not a war, but a cat-fight among our governmental service providers and wannabe providers.

First of all, sovereignty is inherited. It is not something that simply devolves upon us by virtue of winning a war. You have all inherited "sovereignty in your own right" and the right to own property --- as opposed to being considered property -- by being born on the land and soil of your State of the Union.

Second of all, the Delegation of Powers under the Constitutions would not be possible if the Americans had not established Sovereignty. A King can delegate powers to a Queen, or to another King, to exercise in his behalf, but no one of lesser standing can do this. The simple fact that the British Monarch has been in receipt of Delegated Powers of ours since 1787 is all the evidence needed to prove that we possessed sovereignty prior to the establishment of the Constitutions.

Third, our actual claim to sovereignty is based upon the Norman Conquest and a particular kind of sovereignty called "sovereignty in one's own right" that William the Conqueror bequeathed to his loyal Barons in England. In essence, he made land grants to each one following the Conquest, and upon his death in 1087 A.D., he made all of them "sovereigns in their own right" in England.

They were still "Barons" in France, and owed Williams's heir fealty in France; but in England, they were kings with permanent hereditary holdings of land. In England, King John was just one among many kings, and the only distinction of his office was that he was responsible for the maintenance and preservation of the Church's properties and the "Commonwealth" land.

The Commonwealth was co-administered by the Church and amounted to waste land and property that the King entrusted to the Church to develop and manage for the benefit and support of the Paupers, the Sick, and others not able to support themselves.

The Church took over these "commonwealth" properties and used them for good purposes in the communities they served. They used these properties to create common grazing fields, to establish orchards, apiaries, and herb and medicinal gardens, community vegetable gardens, and cemeteries. Rarely, the Church inherited "good wooded ground" --- woodlots, and more rarely still, they were able to convert swamps into arable land via installing drainage ditches, dikes, and dams. The profits were used to support the Church's charity efforts.

So, it was King John's position as "the" King involved in these activities that gave him any special position in England at the time of the Magna Carta; if John had been King of the country in truth and fact, then he could not be held to the Magna Carta longer than the ink was dry and he denied his free-willing consent to it.

The fact that the Magna Carta has stood on the land and soil jurisdiction until this day is again testimony to the fact that the French Norman Barons and their progeny, acting at the time of the Magna Carta--- basically a 128 years after The Settlement of the Norman Conquest, were certainly in possession of "sovereignty in the own right" and as equal kings on the land and soil of England were able to impose their demands lawfully upon King John despite whatever he wanted and despite what the Pope wanted, either.

The Belle Chers, the family of William the Conqueror -- his Cousins and other relatives who remained in England, intermarried and settled in, all as sovereigns in their own right. Their names became Anglicized to "Belcher" and they formed a special alliance with the Clintwoods, a noble English family, an alliance that endured for many generations and followed them to America.

In early America, one branch of the Belchers acted as the Royal Governors of areas that would one day become three States of the Union, but this branch -- headed by Governor Jonathan Belcher, founder of Princeton University, died out; the Belchers who remained in America retained both their ties to England and their ties to the Clintwood family.

William Belcher (the name "William" is retained for many, many generations and derives from William the Conqueror and Guilleroy de Lancelot du Lac the son of King Ban of Gaul, our common ancestor) was here and sided with the Colonists against George III, and as he possessed sovereignty in his own right, inherited from his Norman French ancestors, he was fully competent to stand toe-to-toe with George III, just as the Norman Barons were competent to stand down King John.

Sovereignty operates in the national and international jurisdictions. When sovereignty is changed upon the soil, that is, the national jurisdiction, we see total regime change. The names of countries change. Their systems of government change. Most of the time, challenges to sovereignty occur in the international jurisdiction of the land and sea, with pushing and shoving over trade policies and offshore fishing rights and those sorts of things.

In both cases, whether national or international (domestic or non-domestic) sovereignty is exercised according to the demands of the jurisdiction. On the soil, the sovereign acts as the personification of the people. In the international jurisdiction of the land, the sovereign acts as the Lawful Person personifying the People of a country. In the international jurisdiction of the sea, the sovereign acts as the Legal Person personifying the Legal Personages of a nation.

But what happens when "sovereignty in one's own right" is bequeathed to many people, instead of just one? As William the Conqueror did, and as William Belcher did? Then every man and woman in inheritance of such sovereignty, becomes equal to the King or Queen of any other country, and the entire system of Monarchy is overwhelmed.

From the standpoint of the British Monarchs and the Popes, this is the most damaging part of both the Norman Conquest and the American War of Independence, because it serves to destroy the elitist system of Feudalism (including Corporate Feudalism) upon which they depend. According to their reasoning, for one man to be king, all others must be in subjection.

According to the Williams --- men whose names mean "Resolute Protector"-- this is hogwash. According to them, all Mankind can earn their sovereignty and as far as Americans are concerned, we need only seize upon our birthright and refuse the Nanny State options offered by the Queen and the Popes.

As a result of our unique history and our unique Constitutional system, it has been very hard for them to weasel in and make false claims to the effect that we have knowingly and voluntarily "gifted" our Good Names and Estates to them in exchange for being taken care and bossed around and exploited as property by the Kings and/or the Popes.

It has taken decades and not a little prevarication and clandestine undisclosed contracting processes, plus falsification of records, for them to establish the current system of Corporate Feudalism on our shores --- but all it really takes is for Americans to wake up and remember their inheritance, claim back their birthright political status, and take up the job of being sovereigns in their own right again.

On the soil jurisdiction all such sovereigns are one of the people of the soil, on the land jurisdiction they are one of the People known to be Lawful Persons, and on the international jurisdiction of the sea, they are Legal Persons.

When you return your Legal Person to the land and soil jurisdiction, it becomes a Lawful Person --- owed all the guarantees and protections of the Constitutions. You come back into your birthright inherited status as a "sovereign in your own right".

When you return all the derivative names, including the STRAWMEN to the land and soil and declare their permanent domicile on the land and soil of an American State, they are lawfully converted and they, too, are owed all the guarantees of the Constitutions.

Because sovereignty is inherited from other sovereigns, you cannot avoid being a sovereign in your own right from the moment of your birth, but you can (if it is done consciously and voluntarily -- which in our case, it never is) "pledge" allegiance to other sovereigns or symbols, and become subjected to them as a result.

Generations of American school children have been taught to pledge their allegiance to an inanimate symbol -- the Federal War Flag --- without realizing that they are presumed to be subjecting themselves to the Queen who is flying our own flag under our delegated powers.

Various means of entrapment and identity theft have been used to "capture" and "seize upon" American sovereigns and to unlawfully convert them into US Citizens who are subjects of the Queen and into Citizens of the United States who are subjects of the Popes, but all this activity has been without disclosure, rendering all such pretended citizenship obligations moot and unenforceable so long as you are prepared to stand up and exercise the sovereignty that is your inheritance and birthright--- the sovereignty in your own right --- of all Free Men and Women.

Many questions have been raised about James Clinton Belcher and his role in all this. During the Theodore Roosevelt Administration the Scottish Interloper doing business as "The United States of America, Inc." founded in 1868, was preparing to go bankrupt. James' Great-Uncle, Clintwood Belcher, rode to Washington, DC, to take possession of the Great Seals --- The Great Seal of the United States of America and The Great Seal of the United States.

On his way home, as he crossed over into Maryland, he was viciously attacked by men waiting to ambush him. In the resulting fight, he killed six of his attackers. His own horse was killed also. He grabbed one of the dead men's horses and rode off into the night, making for the western Frontier to save his life.

They stole the Great Seals and they lied about the whole circumstance and branded Clintwood Belcher as a "horse thief" --- neatly omitting their own grand theft under deadly force, their intent to murder, their killing of his horse, and all the rest of it. He spent the rest of his life "on the lam", always looking over his shoulder, always moving from place to place to place. Theodore Roosevelt considered him "a danger to our government"--- self-evidently meaning the foreign Territorial usurpers on our shores.

Clintwood died without issue, so the torch passed to his younger brother, James, and from James to his son Orville, and from Orville to his son, James Clinton Belcher. At the time my husband was born in 1941, Federal Agents were still hunting and harassing members of the family. Orville Belcher moved his young son twelve times in the first ten years of his life, constantly moving just as Great Uncle Clintwood had to move and keep moving to avoid being arrested on false charges or be murdered outright.

This is not a glamorous story. It's a painful, scary, shameful story, in which good men were replaced by bad men, honorable men replaced by crooks, and innocent people who were the victims of crime were portrayed as criminals ----while the actual criminals sat at ease on the White House lawn. The Belchers have lived poor and they have lived rough, but through it all, they remembered who they are. They remembered their hereditary offices. They remembered their lineage. They never ceased the search to recover the Great Seals.

The Great Seals surfaced briefly in New York City in the possession of the Federal Reserve Board of Governors. They have now surfaced again in Indonesia. From our perspective, the Belchers are still the owners of the Seals no matter how many generations of pirates may possess them --- under mandate and Maxim of Law: "Possession by pirates does not change ownership."

Nor, obviously, do any documents that have been impressed with those seals since their theft during the first Roosevelt Administration have any validity or power to bind us, as they have been exercised without our knowledge or consent.

The custodians of the Great Seals in Indonesia are under demand to return them to us as stolen property. If these heirlooms are not returned, we shall have them re-cast in their original form.

It should be noted that the Office of Hereditary Head of State is not a Public Office. It is a Private Trust Office, a Lawful Person, and while it is an Office which James Clinton Belcher claims by direct descent, the reason for doing so is to prove to the Queen that yes, we still exist. It is not only those who received sovereignty at the hands of our ancestor: it is also those who received life from his body and soul who are still here on these shores.

There is no plausible excuse for the Queen or the Pope to continue their pillaging on our shores.

On June 12th, 2011, the Romanus Pontifex was officially collapsed and terminated, via Ritus Mandamus and Ritus Probatum (Public Register Number 983210-331235-01004).

The suffix -ika was first used to create adjectival forms and then names (see regions such as Pays d'Ouche from Utica and Perche from Pertica). The original designation was vague, including a large part of what became Normandy in the 10th century and, in some interpretations, the whole of the coast down to the Garonne. Later, the term became restricted to Brittany.

In Breton, which belongs to the Brythonic branch of the Insular Celtic languages, along with Welsh and Cornish, "on [the] sea" is war vor (Welsh ar fôr, "f" being voiced and pronounced like English "v"), but the older form arvor is used to refer to the coastal regions of Brittany, in contrast to argoad (ar "on/at", coad "forest" [Welsh ar goed or coed "trees"]) for the inland regions.[2] The cognate modern usages suggest that the Romans first contacted coastal people in the inland region and assumed that the regional name Aremorica referred to the whole area, both coastal and inland."

Armorica, populated by French Celtic Armoricians, is on the Breton Peninsula on the sea coast facing across the English Channel. It's people are related directly to the Welsh, Cornish, and to the Irish Ruling Families. It has been one of the great sea-faring nations of the world since the time of the Romans.

Article 581. What Every American Needs to Know About Sir Lancelot

Uther ruled for about twenty years before his son, called Arthur, came to power. Again, "Arthur" is not a name, but a title. It means "The Bear". This practice of associating and naming war chieftains with animal totems runs deep in Celtic tradition.

Ambrosius brokered a marriage for Arthur with the King of Powys's daughter, Guinevere, in hopes of forging a strong alliance in central and western England to continue holding back the Saxon invasion.

The name "Gwynyvver" means "Snow Owl" in the ancient language of the French Celts and is another animal totem title, not a name.

So, the man we know as "King Arthur" was an imported Irish Celt settled in the Welsh Kingdom of Gwynydd and married to a French Celtic Princess from a family settled for some generations in the rich and powerful central English Kingdom of Powys.

They had both grown up in the shelter of Ambrosius's combined remnants of the French and British Celtic Legions. Together, they combined the central powers of what the Romans called "Britain"---- England and Wales.

English and French literature of the Middle Ages tells us that Lancelot showed up at Arthur's court as a knight errant, took an oath to Arthur, and then eventually betrayed it by shagging the old king's wife.

So much for popular fiction.

Lancelot's full name was Guilleroy de Lancelot du Lac.

"Guilleroy" means "William (Resolute Protector) the King"

"de Lancelot" means "of the land"

"du Lac" means "of the lake"

Taking it altogether, "William the King of the Land of the Lake".

Lancelot was Guinevere's much younger kinsmen from France, part of the same French Celtic family as her own, simply living across the channel in Normandy.

Despite 1500 years of propaganda put out by the Usurpers, he was not her lover, though he loved her enough to fight for her and save her from being burned alive for a sin she did not commit.

No, the shoe, so to speak, was on the other foot. The King's foot.

Arthur had extra-marital affairs aplenty, but when Lancelot caught Arthur "at it" with Arthur's own half-sister, the marriage covenant that made Arthur the King of Powys was severed and the crown reverted to Lancelot as the head (by then, both King Ban and King Bors had died some years earlier) of Guinevere's family.

This is how Guilleroy (William) de Lancelot became the lawful king of both Powys and Gaul. It was also the cause of the smear campaign in which Arthur's counselors accused Lancelot and the Queen of the King's own sins.

It is similarly misreported that Galahad was Lancelot's "son", but that is a snide half-truth. Lancelot started life as a Romanized French Celtic noble--- a pagan. He took the baptismal name "Galahad" in Britain upon his conversion to Christianity---- and it was Galahad, that is, the reborn Lancelot, "the son of himself", who found the Holy Grail.

As a French Celtic King of Gaul, Lancelot was born at Joyeux Garde just north of Paris. He returned there after the debacle in Britain, but within a few years, had to defend his land and castle, Camelot, in the Auvergne, against Arthur's half-son, Mordred, and allied Visigoths. Mordred and many misled British Celts died in the battle, and Arthur, repenting of his sins, fought with Lancelot in defense of Camelot---not against him.

Camelot means "charmed land" and it was "the Land of the Lake" that Lancelot was heir to at birth--- the home of "the Lady of the Lake" Lancelot's Mother, Queen Elaine---and also the favorite home of Lancelot's wife, an heiress named Genevieve Brissonnet.

Obviously, if you are looking for Camelot in Britain, you will look a long, long time.

As King of Gaul, Lancelot's holdings stretched from Camelot in the Auvergne in Central France to Bordeaux where the Chateau de Guilleroy carried his name as late as 1933, to Joyeux Garde just north of Paris, and west to the sea in Normandy.

His sons and grandsons kept the truth alive and maintained their claim to the English throne generation to generation until his descendent William of Normandy broached the whole subject with the English King Edward the Confessor.

Edward agreed to honor William's claim to the throne of Powys, which became the throne of England and Wales---- the Roman Kingdom of Britain.

When Edward the Confessor died without having made good and certain of his pledge to William the Norman Conquest ensued. The kinsmen of Guinevere and the heirs of Lancelot came back across the English Channel one more time, and with an ancient score to settle. The senior nobles who came with William of Normandy were all his kinsmen.

The Belle Chers were the Lords of Joyeux Garde just north of Paris, Lancelot's birthplace and also where he died. It was renamed Belle Garde after the Battle of Camlann. As Lancelot himself had written on the lintel of the main gate, it was "Still beautiful, but never again joyous."

The Belle Chers went with William to avenge the betrayal, slander, and attempted murder of Guinevere and to reclaim her throne. When William died, he made each one of them free sovereigns in their own right in England as part of The Settlement of the Norman Conquest.

It is this history that the Sons of the Serpent and their followers try so desperately to hide and misrepresent in order to shore up their own faulty claims. Like their forebears who stole, pillaged, and raped their way to power in the Kingdom of Gwynedd, and just as they did with Guinevere, they continue to commit sins and then accuse other people of them, seeking always to profit themselves at the expense of the just and the gentle and the innocent.

At their core, these "snakes" are cowards, better suited to word games and deceit than war, though they are always keen to force others into war in hopes of standing on the sidelines and profiting from it.

Whatever else happens people of the world--- and no matter what these reptiles say or do--- if they break the peace and dishonor the claims of the Americans to their own land, you will know who is at fault and how these slinking predators operate and what to think of their lies and their motives and their whole lineage from the Dark Ages down to this.

And you will know why these miserable Usurpers run and hide when my husband lifts his hand and head.

Never, ever forget that the Truth is a weapon forged harder than steel, more durable than diamonds, more beautiful than pearls. For all of you who have ever felt that there was something "wrong" and "missing" and "terribly odd" about the Arthurian Legends that have come down to us, now you know the rest of the story.

You know why there is no historical "King Arthur" --- his real name was Owain. Arthur was his totem--- a nickname: "The Bear".

You know why "Camelot" was never found in Britain. It's because it is in the Auvergne.

You know why Queen Bess is outgunned in international jurisdiction by a simple man living in Big Lake, Alaska.

You know why the Norman Conquest happened.

And you are far better educated than most of the crowned heads of Europe.

Testament of Anna Maria Riezinger: Born June 6, 1956

To all the people of the world I leave the Truth of their Divinity and their Mission to merit the gifts they have been given freely by Our Father, the One Life that exists in this One Time called Now, where all that ever was meets with all that ever will be.

Article 3017. The Bleeding of Britain

The Queen is the Agent of the House of Wettin in Britain, and holds a subordinate position to her own Cousin, Lady Somerset, the Dame of Glamis Castle--- the "goddess". This is how and why Continental interests have been bleeding Britain dry for the last eight decades, up to and including the EU and UN. More than half the members of Parliament have personally been on the take and receiving kickbacks from this group of Royal Investors, and still more have been blackmailed by them. It appears to be a collusion between largely Middle Eastern bankers (Muslims and Jews alike) and the various monarchies of Europe seeking to create a new form of Feudalism, which I call "Corporate Feudalism" as it transfers the responsibilities of the Monarch onto the faceless, nameless, unaccountable backs of commercial corporations owned by the Crown, and various other corporations worldwide owned by other investor groups, and all controlled ultimately by the Holy See.

The apparent goal in all of this is to set up a new means to enslave the public as serfs, with all named individuals serving the corporations that "represent" the various states and kingdoms (without being those States or Kingdoms or even necessarily associated with them) and with the Monarchs only serving as figureheads to calm the masses into submission. The object is to control the labor and commodities and natural resources actually owned by the people of the world on a private basis, so as to grossly enrich and empower the few private Parties that control and own both the Crown and the Holy See, and to protect their corporations from such unpleasanties as taxes.

This debasement and dehumanizing of the Monarchy reduces it to the level of any other commercial corporation, whether you call it QEII or ELIZABETH II or LIZZIE, all of which and sundry others have been used as instrumentalities of HER MAJESTY, INC.

This plot subjects the Queen and everything she owns to the authority of the Roman Curia, which makes up all these corporations and other THINGS such as Cooperatives and Limited Liability Partnerships and which serves to define what corporations are and what powers they have and what rules they must abide by and what punishments can be applied to them. It is all bunk--- charlatanism based on the theory and concept of "legal persons" as opposed to "lawful persons", being used to impersonate people and suborn their assets as collateral.

The actual history of this all revolves around criminal misuse and abuse of public trusts that were established under very dubious circumstances, which will be described more fully in our lawful proceedings, but for a good flavor of the actions taken and the results of these actions, please see the United States Federal Code, Title 22, especially the Annotated Revised Statutes at Large.

The history of the Earls of Shovesbury goes back --- not to England, but to the Frankish Kingdom that preceded the First Holy Roman Empire, and a portion of the world that is now considered Southeastern Germany in and around Dresden, and particularly the small town of Issagau, where my own ancestors came from, and the noble family known as the Brakespeares --- for their habit of breaking spears aimed at them, and also, The Order of the Black Arrow, which has its roots in pre-Christian times, but which was much later taken over by the Jesuits and infiltrated by the Nazis.

As is common among the kings and nobles of the Merovingian bloodlines, "v" and "w" -- which is merely a double "v" -- actually stands for the letter-sound "f" in German and related languages, sometimes also written as an "S" in the old handwriting known as Fraktur.

So your name and title on the Continent is different than its later derivative in Britain, and became progressively Anglicized in Britain. Shrovesbury pronounced "Schruuffsbeurie" became Shrewsbury, in the same way as the French Belle Cher was Anglicized to Belcher. Both families ultimately came to Britain through France--- directly in the case of the Belle Chers, and via France from Germany in the case of the Bacons -- the von Specks. And that is why to this day, one still hears both Shovesbury and Shrewsbury, Belle Cher and Belcher.... there are many other examples. All date from before the establishment of the First Holy Roman Empire in 800 A.D.

Sir Francis Bacon was the Earl von Speck --- which means "bacon" in German. As in "bringing home the bacon". You can now also better appreciate his pen name, William Shakespeare -- William means "resolute protector" and Shakespeare is a take-off on the family name, "Brakespeare". In retrospect, it is easy to see that William Shakespeare's message was largely addressed as an admonishment to the Tudor Monarchs, including multiple exposes concerning the reasons for the downfall of the Plantagenets as an object lesson.

This also sheds light on the otherwise completely irrational fire-bombing of Dresden, Germany. Dresden was called "Florence on the Elbe" for its great beauty and artistic treasures, it offered absolutely no military targets at all, yet on the fateful night of February 13, 1945, with the Nazi surrender clearly in view, the Allies staged one of the most devastating attacks in military history against this lone, unfortified, unprotected, helpless, beautiful German city. They murdered 135,000 people, many of them refugees from Eastern Europe fleeing to safety, and nobody when called on the carpet for this atrocity had any excuse that made sense. Why Dresden?

Because what was thought to be the only surviving handwritten copy of Martin Luther's 95 Theses was among the city's treasures. All that misery, destruction, and death was rained down on Dresden by the agents of the Pope, superstitiously and malevolently bent on destroying these few pieces of paper. It will perhaps shame them and give them reason to pause and reflect that: (1) there are other copies written in Martin Luther's own hand; and (2) the content of the work is distributed throughout the world so that everyone knows the criticism Luther issued against the Church. Everyone knows about the sale of "Indulgences" allowing rich men to sin. Everyone is now learning about the sale of children --- and the Church's no longer secret reason for opposing abortion, which has more to do with dollar signs than any care for the sanctity of life.

The pagan sacrifice of Dresden by fire, like the Holocaust, like the World Trade Center bombings, has all been for naught.

We can only call the religion of the Enlightened Ones-- the Hanger's On of the long defunct Roman Empire--- "the religion of the Deceivers"---- and none are so deceived as the members of this cult. The phrase, "the smoke of Satan" does not refer to incense. It refers to the smoke from burning and charred flesh, that of people and of animals. It is said to delight Satan, so that's what his followers, who are ultimately the stupid ones among us, try to feed their "god". The members of this Death Cult are within the clinical definition of insane--- self-destructive and destructive of all mankind.

They substituted themselves and their own cult-followers for the lawful rulers of Great Britain and The United States, much as a magician changes hats and promotes an illusion, but once the "spell" of the illusion is broken, it all falls apart. People awaken from their trance and all the black magic, all the seances with the dead, all the consorting with demons, the orgies, the cannibalism, the drug use, the pornography, the blackmail, the "sacrifices" and even the phony money is exposed for what it is.

We have awakened from this nightmare before our kindred and we have sounded the alarm. At first, nobody paid any attention. They were all too busy trying to earn a living and "get ahead" to think beyond their next working day. Finally, things have deteriorated so much and the rot of this "system" is so blatant that everyone who can still think from Point A to Point B can see the lies of their purported leaders and smell the stench of

this grotesque corruption. We no longer have to argue about the existence of the corruption of our governments worldwide. The only argument is --- what to do about it?

We have stood for educating people to self-govern since 480 A.D. and we still stand for this, as the only lawful and certain and ultimately, humane, answer. This is in accord with Universal Law and it is amply borne out by our earthly experience. A monarchy may be of some use as a fail-safe or safeguard institution, much as we have served in the present moment to bring forward the Public Law, but the ever-changing nature of inheritance and culture means that absent a conscious sharing of the burden of governance people are too easily misled and abused by a relatively few individuals manipulating commodity markets and currencies and legal systems and mercenary armies.

Our conclusion? People must be taught to govern themselves, to think for themselves, to choose what is right and to know what is right, to grow up and discipline themselves, to exercise the entire range of their potential as individuals, to bear responsibility and to exercise rights. They must be given the education, insight, and resources to do so. The idea that we can or should simply extend the role of parents to the government and via the institution of a Nanny State seek to "free" people from such drudgery, results in those entrusted with the government exercising their power in inappropriate, destructive, criminal ways.

Power corrupts and absolute power corrupts absolutely. We have seen this again, and again, and again. There is no rational reason to argue the point.

Power-sharing at an individual level as well as a national level is necessary, just as growing up and accepting the challenges of adulthood is necessary. A free society composed of healthy, honestly educated, empowered, and actively participating people who are fully engaged in rational self-governance, is the only safeguard to overall well-being on this planet. We can't create this healthy dynamic by entrusting our fate to kings or conglomerates. Each one of us has to take responsibility and give a shove in the right direction.

We hope that this little dissertation has shed light upon the darkness of some very unsavory history and circumstances, and may also, we hope, give you some inspiration and needed insight into the broader issues of your own inheritance.

Life was the greatest gift, the most holy of all, the most to be honored and be grateful for.

He could go on for hours with his inner vision fixed on what other men could only see by his words, and they, too, became enraptured and empowered, and rose up from whatever station of life they were in, to live and breathe and think of themselves as kings within their homes and villages---- kings with duties, kings with honor, kings with moral fiber and vision, each one serving The True God Within.

Many miracles occurred, and great transformations in the way people thought of themselves and behaved. And then, the Roman Catholic Church came, and branded his vision of man and "God Within Man" a heresy, contrary to the dogma of the Church and its dreary vision of guilt and suffering and alienation from The True God Within--- alienation that could only be cured, at a price, via the intercession of priests and their doling out of Communion.

The genesis of America as a modern nation lies in the far distant past when the hardy sea-faring people of the Normandy coast known as Armoricans, a tribal nation within the Kingdom of Gaul, began trading with the Natives of what is now known as Nova Scotia and the Northeastern United States for furs. This trade was established and recorded in Roman times and continued unabated for at least 600 years, most recently evidenced by the French and Indian Fur Trade we still read about in our history books.

It is from the Armoricans that America inherits its name and so far as European colonization and government goes, it is with the Government of Gaul that it all begins. Gaul is the ancient Roman name for France and it was under the Kingdom of Gaul that the original Armorican trade in furs began. The Belle Chers are the equally ancient and dominant tribal nation of Gaul and the chieftain-kings of Normandy, including the land and blood of the Armoricans.

So in fact the first European claims concerning this country result from the Armorican Fur Trade and the very name of this country -- America -- is a British transliteration of Armorican.

As the tribal chieftains of Gaul, the Belle Chers and their nations own all of France and their peoples also populate and own the Kingdoms of Aragon and Castille in Spain, and the Kingdom of Powys in Central England.

From Powys these European tribal chieftains migrated to America in 1608. They have remained in this country and populated it ever since. Those who came to this country were independent sovereigns in their own right as a result of The Settlement of the Norman Conquest in 1087 A.D. and kinsmen of William of Normandy, of the same family and lineage.

James Clinton Belcher --- Belcher being the British transliteration of Belle Cher -- is the chieftain of the Belle Chers in America. His ancestral name in France is Guilleroi de Armentois du Lac and the honorable history of his House of Belle Garde in Northern France is well-known. It is his Coat of Arms that forms the basis of the Great Seals of both the United States and the United States of America.

Thus by both name and shield, and by history of service of his ancestor William Belcher of Connecticut in the Continental Army and afterward, the history of America on land and sea is inextricably connected to France as well as Spain and England, and by dust and by blood they make One Compact via the hand of the Clan Chieftain of the Belle Chers, who has summoned the actual States of this country into Session.

All of the jurisdictions of the law, national, international and global, all the local forms of law engaged in by our country and our countrymen, come together in One Compact.

Article VI Section 2 of all three Federal Constitutions fully admits that Treaty is the highest form of law among nations and that all treaties are honored including those concluded prior to the settlement of The War of Independence; the new American Government assumed all treaty debts, obligations, and contracts.

This allows us to be sure that this country functions in all respects in a single unbroken Compact and our knowledge and physical presence guarantees that that Compact has never been vacated at any time; thus, *bono vacantia* does not apply and ownership interest in this country is not limited to those Principals present in 1776, but includes a far more venerable heritage.

The Mayflower Compact signed November 11th of 1620 according to the Julian Calendar forms the first public declaration of law brought forward by the English settlers coming to these shores, but even prior to that, the British-lineage Belchers had established their own Testament and Declaration of Law in 1608, when they arrived in Boston, Massachusetts and began building the Old South Church.

Both of these foundations are international treaties established by sovereign Principals, inherited under Article VI, Section 2. Both pre-date the earliest known treaties with North American Indian tribes: they predate The Treaty of Fort Pitt, also known as the Treaty with the Delawares, by over a hundred and fifty years.

Likewise, our Seat of Government and General Post Office for The United States of America comes by Treaty with the Belle Chers in Spain in 1702, and has been established in Philadelphia, Pennsylvania, since 1732. To this day, The United States of America is not a member of the Universal Postal Union, and maintains its own separate service and private postal designations. James Clinton Belcher is the American Post Master on the land and the American Postmaster on the sea by International Treaty and inheritance pre-dating The War of Independence. This is the foundational Postal Treaty that connects our country to postal services on an international and private basis.

The United States Post Office by contrast was established by Benjamin Franklin in 1778 and also located in Philadelphia, Pennsylvania, to serve the United States bureaucracy, and the citizenry of the United States including the Native American Tribes subscribing to Roman Civil Law and Municipal citizenship. The USPS is a member of the Universal Postal Union and operates in global commerce.

Both of these Postal Treaties are vital to the proper functioning of our country as a member of the community of nations, and both must be honored and regulated according to our published treaties and constitutional agreements.

When we re-issued our Sovereign Letters Patent on 4th November of 2015 according to the Gregorian Calendar, we served the Principals and International Courts with our action as The United States of America--our unincorporated Federation of States; when we issued the Joint Sovereign Letters Patent on 6th November 2015 according to the Gregorian Calendar, we established a Treaty of Peace between ourselves and the Native American nations of the United States.

Never again will Native Americans suffer the atrocities and alienation from the land and soil that they have suffered for the last 150 years.

All these actions, all these agreements on air, land, and sea, make for peace and for plenty for all people; they are treaties stretching into the distant past and into the freedom of the future, woven into one tapestry of living history memorialized, One Compact of Law which belongs to everyone.

We call upon the High Courts of every jurisdiction to bow to the logic and the history, the signs and the symbols and names which cannot be erased, the noble purposes and intentions that have inspired us for centuries, and the end of the spiritual war which has been based on the delusion of separateness.

Nothing could be farther from the Truth. It is a disservice so vile that I feel compelled to mount my bully pulpit and point out that the word "people" means "militia" in Hebrew, and that is and was and still remains its meaning: "We, the Militia...."

Two hundred and forty-one years ago, if the history books are to be believed about anything, the original organizers of the government of this country were hard at work in Philadelphia, Pennsylvania. It was overcast and the dank, damp air rising from the squalid city streets combined with the heat of summer made John Adams describe the atmosphere as "fetid". As the shock waves of the unanimous vote died slowly away, the members of the Continental Congress began to wake up to the new realities of July 5th, 1776. After ten years and more of wobbling back and forth, it was finally decided.

One is reminded of that moment when, having struggled with a terrible disease for a long time, the doctor finally delivers a diagnosis. Suddenly, the problem solidifies, takes on a name, dimensions, and a known character.

So it is, that we, too, have come awake and begun the process of dealing with the consequences of our decisions. Like our Forefathers, we face the razor-edge of supporting The Declaration of Independence with "our lives, our fortunes, and or sacred honor" --- or not, in our own country.

I, despite my misgivings, had to exercise the hereditary office as American Head of State, to bring correction and restoration.

Do not be deceived by any new corporation taking over the reins in Washington, DC., and proclaiming themselves some kind of "republic". A corporation is incapable of being a republic by definition.

The actual states are named simply, like this: Alabama, Alaska, Arizona, Arkansas.... The unincorporated businesses charged with conducting the affairs of the actual states are named like this: Alabama State, Alaska State, Arizona State, Arkansas State.....

All these organizations that you see operating as "States of States" like State of Washington and State of Louisiana are merely franchises of the Territorial federal government. All the "STATES OF STATES" like the STATE OF WISCONSIN and STATE OF IDAHO are similarly franchises of the Municipal federal government, and strictly speaking, shouldn't even be on our soil.

A great deal of self-interested pillaging and plundering has taken place in America as a result of the mismanagement and dishonesty of both the Territorial and Municipal Governments. The Congress in presiding over both these foreign governments has proven both incompetent and disloyal to their true duty to the American states and people.

Beginning in 2007 and continuing more or less unabated through 2015, a Master Plan was put in motion by corrupt mostly foreign banking interests to pull off a reprise of the Great Fraud practiced upon us by Franklin Delano Roosevelt.

On that occasion, similar names deceits mis-characterizing the Trade Names of American landmen as Foreign Situs Trusts belonging to the bankrupt United States of America, Incorporated, were used to set up a process of debt assumption, by which millions of innocent Americans and their assets were "presumed" to be franchises of the failed corporation and collateral for its debts.

Three generations of Americans have toiled as debt slaves and given up large percentages of our private earnings to pay off the debts of this foreign, mostly privately owned governmental services corporation merely calling itself the "United States of America"----Incorporated. It was finally released from bankruptcy November 7, 1999.
